The Bourse and CDCC wish to inform you that Turquoise Hill Resources Ltd. (“Turquoise Hill”) rights that are included in the TRQ1 option class will expire on Tuesday, January 7, 2014. Therefore, the rights will be removed from the deliverable of the TRQ1 option class at the opening of business on Friday, January 3, 2014.

Pursuant to Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all the Turquoise Hill options will be adjusted as follows:

- **POSITION AND EXERCISE LIMITS** **Unchanged**
