The Bourse and CDCC wish to inform you that the trading symbol on the Toronto Stock Exchange for Open Text Corporation will change from “**OTC**” to “**OTEX**”. The company will start trading under the new symbol on the Toronto Stock Exchange at the opening of business on February 6, 2017.
