The Bourse and CDCC wish to inform you that the Directors of Labrador Iron Ore Royalty Corp. (“Labrador”) announced on March 2, 2017 a special cash dividend of \$0.25 CDN per Common share (the “Special Dividend”) to its shareholders. This dividend is payable on April 25, 2017 to participating shareholders of record at the close of business on March 31, 2017. The ex-dividend date is March 29, 2017.

The Bourse and CDCC will take into account the special dividend by adjusting the strike prices of Labrador Iron Ore Royalty Corp. (LIF) options, by an amount equivalent to the special dividend that is \$0.25 CDN.
