FINAL CONTRACT ADJUSTMENT Minefinders Corporation Ltd. (MFL) Plan of Arrangement

THIS DOCUMENT IS AN UNOFFICIAL SUMMARY OF CERTAIN TERMS OF THE AFOREMENTIONED ADJUSTMENT. CDCC AND THE BOURSE ACCEPT NO RESPONSIBILITY FOR THE ACCURACY OR COMPLETENESS OF THE SUMMARY. CDCC MEMBERS AND BOURSE APPROVED PARTICIPANTS MUST ENSURE THEY HAVE REVIEWED THE DOCUMENTATION PUBLISHED BY THE ISSUERS INVOLVED IN THIS CORPORATE ACTION.

The Bourse and CDCC wish to inform you that Minefinders Corporation Ltd. (“Minefinders”) announced that it has received approval from its Shareholders concerning the recently effected plan of arrangement involving Minefinders and Pan American Silver Corp. (“Pan American”). Pursuant to this arrangement, the common shares of Minefinders will be delisted from the Toronto Stock Exchange at the close on Wednesday, April 4, 2012. Each Minefinders Shareholder is entitled to receive, per Share, either: (i) 0.55 shares of Pan American and C\$1.84 in cash; or (ii) 0.6235 shares of Pan American and C\$0.0001 in cash; or (iii) 0.5423 shares of Pan American and C\$2.0306 in cash. Option (i) being the default option.

Pursuant to Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all Minefinders options will be adjusted as follows:
