The Bourse and CDCC wish to inform you that the cash amount equal to 0.67 common shares of NovaCopper Inc. ("NCQ") that is included in the new deliverable per NG1 contract has been set at CAD\$2.53. In accordance with the Circular No. 063-12 and the Notice to Members No. 071-12 dated April 23, 2012, this cash amount is equal to the closing price of NCQ on May 1, 2012 times 0.67. Hence, the new deliverable per NG1 contract is as follow:

100 common shares of NovaGold (NG) and 16 common shares of NovaCopper (NCQ) and a cash portion equivalent to 0.67 common shares of NCQ which is equal to CAD\$2.53

The cash amount of the deliverable will remain permanently fixed as the option deliverable and will not vary.
