FINAL CONTRACT ADJUSTMENT Shopify Inc. (SHOP & FSH) Stock Split

The Bourse and CDCC wish to inform you that Shopify Inc. Class A subordinate voting shares ("Shopify") (TSX:SHOP) (NYSE:SHOP) announced on June 7, 2022 that its Board of Directors has approved a ten-for-one stock split of all its outstanding common shares.

Shareholders of record on June 22, 2022 will receive nine additional common shares on June 28, 2022, for every share held.

The shares of Shopify will begin trading on a ten-for-one split basis on the Toronto Stock Exchange at the opening of business on June 29, 2022.

The Shares will commence trading on a "due bill" basis at the opening on June 21, 2022.

Due Bill Trading will end at the close of business on June 28, 2022.

The Ex-distribution date will be deferred through the use of Due Bills to the first trading day following the payable date (June 29, 2022).

Stock Split - Adjustment Details:

CDCC - Adjustment Details - Option:

Pursuant to Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all Shopify Inc. options will be adjusted as follows:

- **EFFECTIVE DATE:** June 29, 2022
- **OPTIONS SYMBOL:** Unchanged
- **NUMBER OF CONTRACTS:** Decupled
- **MULTIPLIER:** 100
- **DELIVERABLE PER CONTRACT:** 100 common shares of Shopify Inc Class A subordinate voting shares.
- **STRIKE PRICES:** An adjustment will be made for all existing series
- **POSITION AND EXERCISE LIMITS:** Position and exercise limits will change to 250,000 contracts
- **CUSIP :** Unchanged

CDCC will not adjust any outstanding escrow receipts. Members who want to maintain margin relief for all their positions will be required to deposit additional escrow receipts.

Bourse de Montréal Inc. Adjustment Details - Option:

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the stock split and will therefore have to **be re-entered** into the Montreal Automated System (SAM) by the approved participants.

At the opening of business on June 29, 2022 the Bourse will adjust the strike prices for Shopify Inc. series as indicated below. Please note that the table below is subject to change due to market fluctuation.
