FINAL CONTRACT ADJUSTMENT Morneau Shepell Inc. (MSI) Name, CUSIP and Symbol Change

The Bourse and CDCC wish to inform you that “Morneau Shepell Inc.” will change its name to “Lifeworks Inc.”

The company will start trading under the new name, CUSIP and symbol on the Toronto Stock Exchange at the opening of business on May 20, 2021.

CDCC - Adjustment Details:

Pursuant to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all the “Morneau Shepell Inc.” options will be adjusted as follows:

- **EFFECTIVE DATE:** **May 20, 2021**
- **OPTIONS SYMBOL:** **MSI will become LWRK**
- **NUMBER OF CONTRACTS:** **Unchanged**
- **MULTIPLIER:** **Unchanged**
- **DELIVERABLE PER CONTRACT:** **100 Common shares of Lifeworks Inc.**
- **STRIKE PRICES:** **Unchanged**
- **POSITION AND EXERCISE LIMITS:** **Position and exercise limits will remain unchanged at 50,000 contracts**

Bourse de Montréal Inc. - Adjustment Details:

The existing series of MSI options class will be transferred to the LWRK options class representing the new deliverable.
