FINAL CONTRACT ADJUSTMENT Tourmaline Oil Corp. (TOU & FOU) Special Cash Dividend

The Bourse and CDCC wish to inform you that the Directors of Tourmaline Oil Corp. (the "**Corporation**"), declared on July 27, 2022, a special cash dividend of CAD \$2.00 per common share. The special dividend will be paid on August 12, 2022 to shareholders of record as of the close of business on August 5, 2022. The ex-dividend date is August 4, 2022.

The Bourse and CDCC will take into account the special dividend by adjusting the strike prices of Tourmaline Oil Corp. (TOU) options, by an amount equivalent to the special dividend that is CAD \$2.00.
