The Bourse and CDCC wish to inform you that “Penn West Petroleum Ltd.” has changed its name to “Obsidian Energy Ltd.” and its trading symbol from “PWT” to “OBE”. The company will start trading under the new name, symbol and CUSIP on the Toronto Stock Exchange at the opening of business on June 29, 2017.
