The Bourse and CDCC wish to inform you that the cash amount equal to 0.2 common shares of Molycorp, Inc. ("Molycorp") that is included in the new deliverable per NEM1 contract has been set at C\$4.10. In accordance with the Circular No. 091-12 and the Notice to Members No. 112-12 dated June 14, 2012, this cash amount is equal to the closing price of Molycorp on June 14, 2012 times 0.2, times the US/CAD exchange rate from Bank of Canada on June 14, 2012. Hence, the new deliverable per NEM1 contract is as follow:

## > <u>NEW DELIVERABLE PER</u> <u>CONTRACT:</u>

C\$805 in cash and 12 common shares of Molycorp and a cash portion equivalent to 0.2 common shares of Molycorp which is equal to C\$4.10

The cash amount of the deliverable will remain permanently fixed as the option deliverable and will not vary.
