FINAL CONTRACT ADJUSTMENT Tourmaline Oil Corp. (TOU & FOU) Special Cash Dividend

The Bourse and CDCC wish to inform you that the Directors of Tourmaline Oil Corp. (the "**Corporation**"), declared on November 2, 2022, a special cash dividend of CAD \$2.25 per common share. The special dividend will be paid on November 18, 2022 to shareholders of record as of the close of business on November 9, 2022. The ex-dividend date is November 8, 2022.

The Bourse and CDCC will take into account the special dividend by adjusting the strike prices of Tourmaline Oil Corp. (TOU) options, by an amount equivalent to the special dividend that is CAD \$2.25.

Special Dividend - Adjustment Details:

- **RECORD DATE:** November 9, 2022
- **PAYABLE DATE:** November 18, 2022

CDCC - Adjustment Details:

According to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all Tourmaline Oil Corp. (TOU) options will be adjusted as follows:

- **NUMBER OF CONTRACTS:** Unchanged
