The Bourse and CDCC wish to inform you that Ivanhoe Mines Ltd. (IVN) will change its name to Turquoise Hill Resources Ltd. (TRQ). The common shares of the company will start trading under the new name, symbol and CUSIP on the Toronto Stock Exchange at the opening of business on **August 8, 2012**.
