FINAL CONTRACT ADJUSTMENT Canadian Energy Services & Technology Corp. (CEU) Stock Split

CDCC MEMBERS AND BOURSE APPROVED PARTICIPANTS MUST ENSURE THEY HAVE REVIEWED THE DOCUMENTATION PUBLISHED BY THE ISSUERS INVOLVED IN THIS CORPORATE ACTION.

The Bourse and CDCC wish to inform you that Canadian Energy Services & Technology Corp. (the "CESTC") announced on June 19, 2014 that the due bill trading procedures will apply to its stock split. Corporation shareholders of record on July 18, 2014 will receive two additional shares payable on July 23, 2014, for every share held. The common shares of the Corporation will begin trading on a three-forone split basis on the Toronto Stock Exchange at the opening of business on July 24, 2014.

The ex-distribution date will be deferred through the use of Due Bills to the first trading day following the payable date.

CDCC will not adjust any outstanding escrow receipts. Members who want to maintain margin relief for all their positions will be required to deposit additional escrow receipts.

Bourse de Montréal Inc. Adjustment Details:

It is important to note that on the effective date mentioned above, all open orders on this option class <u>will</u> <u>not be automatically modified</u> to reflect the stock split and will therefore have to <u>be re-entered</u> into the Montreal Automated System (SAM) by the approved participants.

At the opening of business on July 24, 2014, the Bourse will adjust the strike prices for the CESTC series as indicated below. Please note that the table below is subject to change due to market fluctuation.
