FINAL CONTRACT ADJUSTMENT DHX Media Ltd. (DHX) Rights Offering

THE FOLLOWING INFORMATION IS PREPARED FOR THE CONVENIENCE OF CANADIAN DERIVATIVES CLEARING CORPORATION (CDCC) MEMBERS AND BOURSE DE MONTRÉAL INC. (THE BOURSE) APPROVED PARTICIPANTS. THIS DOCUMENT IS AN UNOFFICIAL SUMMARY OF CERTAIN TERMS OF THE AFOREMENTIONED ADJUSTMENT. CDCC AND THE BOURSE ACCEPT NO RESPONSIBILITY FOR THE ACCURACY OR COMPLETENESS OF THE SUMMARY. The Bourse and CDCC wish to inform you that DHX Media Ltd. (dba WildBrain) ("WildBrain" or the "Company") announced on October 9, 2019 that shareholders of record on October 18, 2019 will receive 1 Right ("Right") for every common voting shares ("Common Voting Shares") and variable voting shares ("Variable Voting Shares" and, together with the Common Voting Shares, "Voting Shares") held on the record date.

Every 3.757635354 Rights will entitle the holder to subscribe for one whole Voting Share of the Company at a price of CAD \$1.67 per Voting Share (the "Subscription Price").

The Rights will start trading on the Toronto Stock Exchange on October 17, 2019, until November 15, 2019 at noon Eastern Standard Time (EST), and they will expire at 5:00 p.m. Eastern Standard Time (EST) on November 15, 2019. The Rights will be listed on the TSX under the symbol "DHX.RT".

CDCC - Adjustment Details:

Pursuant to Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all the DHX options will be adjusted as follows:

The Bourse - Adjustment Details:

It is important to note that on the effective date mentioned above, all open orders on this option class <u>will not be automatically modified</u> to reflect the rights offering and will therefore have to <u>be re-entered</u> into the Montreal Automated System (SAM) by the approved participants.

The existing series of DHX options class will be transferred to the DHX1 options class representing the new deliverable.
