The Bourse and CDCC wish to inform you that “Amaya Inc.” has changed its name to “The Stars Group Inc.” and its trading symbol from “AYA” to “TSGI”. The company will start trading under the new name, symbol and CUSIP on the Toronto Stock Exchange at the opening of business on August 1, 2017.
