The Bourse and CDCC wish to inform you that Horizons ETFs Management (Canada) Inc. ("Horizons"), the manager of the ETFs, is reorganizing the ETFs currently structured as trusts, into a corresponding class of shares of a new multi-class corporate fund structure to be managed by Horizons (the "Reorganization").

Pursuant to the Reorganization, each class A unit (the "Class A Units") of each ETF will be exchanged for one share of a corresponding ETF series of shares of the ETF (the "ETF Shares").
