FINAL CONTRACT ADJUSTMENT WestJet Airlines Ltd. (WJA) Plan of Arrangement

The Bourse and CDCC wish to inform you that WestJet Airlines Ltd. ("WestJet")(TSX: WJA) and Onex Corporation ("Onex")(TSX: ONEX) announced on December 11, 2019, the completion of their previously announced plan of arrangement.

Pursuant to the terms of the Plan of Arrangement, common shareholders of WestJet Airlines Ltd. will receive CAD \$31.00 for each issued and outstanding common share held.

The common shares will be delisted from the Toronto Stock Exchange at the close of business on December 13, 2019.

CDCC - Adjustment Details:

Pursuant to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all WestJet Airlines Ltd. (WJA) options will be adjusted as follows:

- <u>EFFECTIVE DATE:</u> December 16, 2019
- OPTIONS SYMBOL: WJA will become ONEX2
- <u>NUMBER OF CONTRACTS:</u> unchanged
- MULTIPLIER: 100
- STRIKE PRICES: Unchanged
- NEW DELIVERABLE PER CONTRACT: A cash consideration of CAD \$3100.00
