### FINAL CONTRACT ADJUSTMENT BetaPro Canadian Gold Miners -2x Daily Bear ETF (HGD) Reverse Split

The Bourse and CDCC wish to inform you that “BetaPro Canadian Gold Miners -2x Daily Bear ETF” (TSX: “HGD”) will consolidate its Common Shares.

The reverse split on the basis of a one-for-twelve ratio will be effective at the opening of the markets on November 28, 2024.

#### **CDCC - Adjustment Details:**

Pursuant to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all HGD options will be adjusted as follows:

- **EFFECTIVE DATE:**                      **November 28, 2024**
- **OPTIONS SYMBOL:**                      **HGD will become HGD1**
- **NUMBER OF CONTRACTS:**              **Unchanged**
- **MULTIPLIER:**                              **100**
- **NEW DELIVERABLE PER CONTRACT:**      **8 common shares of BetaPro Natural Gas Leveraged Daily Bull ETF (HGD) and a cash consideration equivalent to 0.3333 (100 x 0.003333) of a HGD share. A follow-up circular will confirm the amount.**
- **STRIKE PRICES:**                          **Unchanged**
- **NEW CUSIP :**                                **Unchanged**
- **POSITION AND EXERCISE LIMITS FOR HNU1:**      **Position and exercise limits will remain unchanged at 250,000 contracts**



**CDCC will not adjust any outstanding escrow receipts.**

**The Bourse - Adjustment Details:**

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the reverse split and will therefore have to **be re-entered** into the SOLA Trading System by the approved participants.

The existing series of HGD options class will be transferred to the HGD1 options class representing the new deliverable.

<b>Actual Class Symbol</b>	<b>New Class Symbol</b>
HGD	HGD1

Please note that only closing transactions will be permitted on the adjusted class. Actual series that do not have open interest will not be adjusted.

**Numerical Example - HGD (HGD1)**

For a member holding a long put strike \$3.00 position and considering that closing price on November 22, 2024 is \$2.24, the intrinsic value of the option prior to the adjustment is:

$$\begin{aligned} \text{Intrinsic Value} &= \$3.00 \times 100 - \$2.24 \times 100 \\ &= \$76.00 \end{aligned}$$

After the adjustment, the intrinsic value of the option will be:

$$\begin{aligned} \text{Intrinsic Value} &= \text{Strike Price} \times \text{Multiplier} - \text{New Underlying Price} \times \text{New Deliverable} \\ &= \$3.00 \times 100 - \$26.88 \times (100/12) \\ &= \$76.00 \end{aligned}$$
