FINAL CONTRACT ADJUSTMENT BetaPro Canadian Gold Miners - 2x Daily Bear ETF (GD XD) Reverse Split

The Bourse and CDCC wish to inform you that BetaPro Canadian Gold Miners - 2x Daily Bear ETF (TSX: "GD XD") will consolidate its Common Shares.

The reverse split on the basis of a one-for-five ratio will be effective at the opening of the markets on November 27, 2025.

CDCC - Adjustment Details:

Pursuant to the Terms of Adjustment provided in Section A-902 of the Rules of CDCC, all GD XD options will be adjusted as follows:

- **EFFECTIVE DATE:** **November 27, 2025**
- **OPTIONS SYMBOL:** **GD XD will become GD XD2**
- **NUMBER OF CONTRACTS:** **Unchanged**
- **MULTIPLIER:** **20**
- **NEW DELIVERABLE PER
GD XD2 CONTRACT:** **20 common shares of BetaPro Canadian Gold Miners -
2x Daily Bear ETF**
- **STRIKE PRICES:** **Strike Prices will be multiplied by five**
- **NEW CUSIP :** **08661P 50 3**
- **POSITION AND EXERCISE
LIMITS FOR GD XD2:** **Position and exercise limits will change to 25,000
contracts**

CDCC will not adjust any outstanding escrow receipts.

The Bourse - Adjustment Details:

It is important to note that on the effective date mentioned above, all open orders on this option class **will not be automatically modified** to reflect the reverse split and will therefore have to **be re-entered** into the SOLA Trading System by the approved participants.

The existing series of GD XD options class will be transferred to the GD XD2 options class representing the new deliverable.
