THIS DOCUMENT IS AN UNOFFICIAL SUMMARY OF THE TERMS OF THE AFOREMENTIONED SPECIAL CASH DIVIDEND. CDCC AND THE BOURSE ACCEPT NO RESPONSIBILITY FOR THE ACCURACY OR COMPLETENESS OF THE SUMMARY.

Bourse de Montréal Inc. (the "Bourse") and Canadian Derivatives Clearing Corporation ("CDCC") hereby inform you that on May 6, 2004, BCE Emergis Inc. ("IFM") announced, subject to shareholder approval, a special cash distribution of \$1.45 per share. The ex-distribution and record dates for this cash distribution are June 23, 2004 and June 25, 2004 respectively. Furthermore, the payable date for this dividend is to be June 30, 2004.

Upon receipt of the confirmation of shareholder approval, the Bourse and CDCC will reduce all strike prices by the value of the distributed dividend, i.e. \$1.45. The symbol (IFM) for BCE Emergis Inc. equity options will remain unchanged.
