These figures are based on the July 31, 2004 financial statements. The maximum value of Letters of Credit and Bankers' Acceptances will be implemented with trade processing of Monday, October 4, 2004.

CDCC will continue to evaluate and adjust the maximum value of Letters of Credit and Bankers' Acceptances, and an updated list will be distributed quarterly.
